## NVQ L6 Construction Site Management

**Our Level 6 NVQ Diploma in Construction Site Management is designed for experienced construction professionals aiming to progress into senior site management and leadership roles.**

Candidates will demonstrate their competence in managing construction site operations, health and safety, project planning, and stakeholder engagement. With a strong focus on leadership, decision-making, and communication, successful candidates will be prepared to lead construction teams, manage large-scale projects, and ensure delivery on time, within budget, and to quality standards.

There are four pathways to choose from:

1. **Building and Civil Engineering**
2. **Highways Maintenance**
3. **Residential Development**
4. **Retrofit**

Each pathway has additional mandatory units and a choice of optional units to tailor to your role.

Completing an NVQ doesn't require you to take traditional exams. Instead, assessment is based around your competency in fulfilling your job role duties to meet occupational standards. Assessors will evaluate you based on the contents of your portfolio. It's essential to maintain this portfolio with evidence showcasing the tasks, duties, and accomplishments you've accomplished in work.
